OUSL AIR is a university wide internal			

- OUSL AIR is a university wide internet service provided by The Open University of Sri Lanka(OUSL), Managed by OUSL IT Division to its students for the sole purpose of supporting better collaboration of students to the world
- OUSL AIR is a free internet service intended for registered and active students of the university. If and when a student doesn't register for a particular year, the service will be terminated without prior notification.
- OUSL AIR is a supplementary service hence, if you need more reliable and dedicated network service for research activities, students should use OUSL Wired Network through respective student LABS.
- Students are entitled to register one device and for three registration changes per year.
- OUSL AIR is maintained on the intention of providing a fair service to its entire student community equally. Therefore following usage requirements should be maintained at every time. Failure to do so will terminate the connectivity temporally or permanently according to the violation.
 - o A Fair Usage should be maintained at every time. High usage (Direct, Streaming etc.) should not be used even for educational purpose.
 - OUSL AIR should be solely used for "internet" and "e-mail" through common standard ports-(http, https, POP3, IMAP, SMTP). Usage of any other protocols (torrent, limewire, ftp etc..) will
 - Students should always be physically within the OUSL premises to use OUSL AIR.
- Students should maintain AntiVirus and AntiMalware protection for its devices and will be responsible for virus/malware and network attacks originated from them.
- Students should not disclose the OUSL AIR credentials or allow any other person to access the network through them. Students will be solely responsible for the security of the credentials provided.
- While IT Division will try its best to support the users whenever possible, client device configuration will not be
- OUSL AIR is not recommend using for critical activities and should contact IT Division formally for any such activity

- OUSL AIR users are automatically agreed to adhere and respect Intellectual Property Rights, thus violations such as illegal downloads, streaming and sharing is prohibited and violations will be act upon immediately.
- While maintaining a respective service level, signal strength and allocated bandwidth, availability is not guaranteed and will changed time to time due to fair usage enforcements, beamforming etc..
- While respecting user's privacy, usage will be monitored for the purpose of policy enforcements and legal purposes.
- Using OUSL AIR for hacking, cracking and interfering other users or services is strictly prohibited and will be subjected to disciplinary actions to be initiated through legal channels.
- OUSL IT Division has the sole right to implement any enforcement, service terminations temporarily without prior notification.
- OUSL management will have the sole authority to implement, change, and remove existing and new policies
 permanently or temporally at any given time without prior notification.
- OUSL AIR is under the university IT usage policy and all related policies, thus will be superseded by them including all above mentioned points.
