Special Instructions to Re-Registration without Academic Counselling Bachelor of Pharmacy Honours Degree Programme

- This is a short guide for selecting courses without academic counselling. If you are competent in selecting the courses and if you are conversant with the system, you can select courses in your own. In that case, you can complete your re-registration without academic counseling according to the instructions given in this guide.
- Please note that the student is the responsible person for his/her own course selection. Department of Pharmacy will not take any responsibility in your individual course selection.
- Take a hard copy of your recently downloaded (from MyOUSL) RESULT HISTORY/ SHEET.
- In your RESULT HISTORY/ SHEET you may find following terms.
 - Resit Students who are eligible but failed to obtain a minimum pass mark at the Final Examination. Resit candidates need NOT to re-register for the course at the subsequent registration.
 - o Repeat
 - Students failing to obtain eligibility to sit the Final Examination for a course. Repeat students have to re-register for the relevant course in a subsequent year by re-paying the tuition fee.
 - Students who obtained eligibility but failed at the final examination within two attempts provided.
 - Pending -Final examination results are not released yet for the course. You can select such courses during Add/drop period if necessary.
- First step is to check your current progress. Carefully check your results sheet and identify the courses you need to register for this academic year in the last column. Please consider the following when you select courses.
 - O To complete BPharm Hons Degree, you must complete a total of 30 credits per each level.
 - In level 05, you should complete all the compulsory courses (28 credits) and only one course (02 credits) from the optional courses.
 - o In level 06, you should complete all the compulsory courses (28 credits) and only one course (02 credits) from the optional courses.
 - O You must either complete or maintain concurrent registration for all the lower-level courses before selecting courses at the higher level.
 - Pre-requisites are mentioned in the table for your reference.

- You can decide the number of credits you want to register for this academic year up to a maximum of 30 credits, based on your capacity and time available for studies.
- You are strongly advised to balance your credits between two semesters when selecting courses. Check the semester that offers each course given in column 5.
- Finally, mark the courses you wish to register for this academic year with an 'X' in the first blank column of the Re-registration Form (Without academic counselling) and place your signature by agreeing that you take the responsibility of your own course selection.
- If you have not completed the compulsory courses in the StART@OUSL programme, you are advised to register and complete the particular courses within this academic year (2023/24).
